PRESIDENT'S MESSAGE



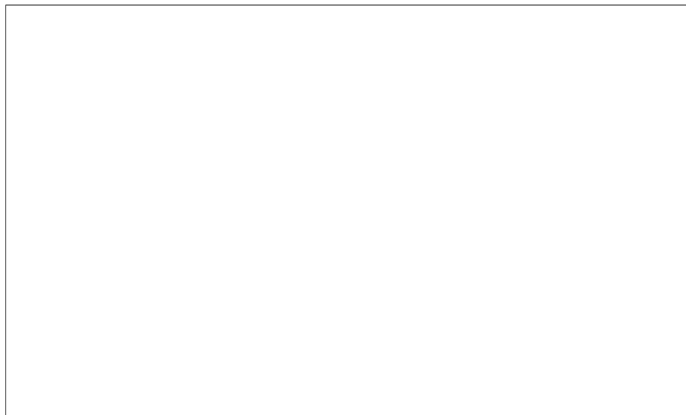

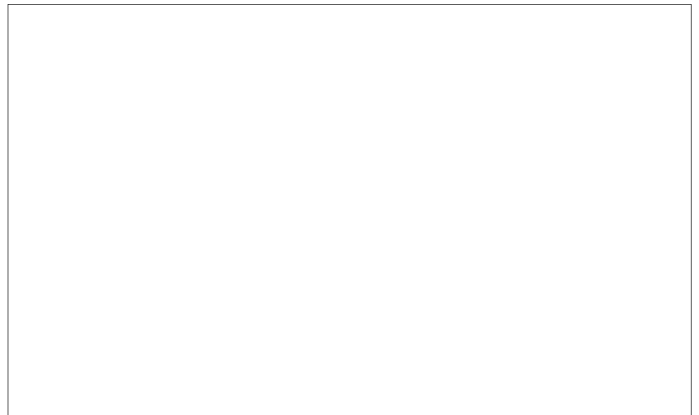
