PRESIDENTS MESSAGE

GETTING YOUR RENEWAL IN ON TIME

Brothers & Sisters, frequently I get inquiries regarding the status of a member's FOP cards and decals. I thought that an explanation of how the renewal process works would help the membership understand why it's to your advantage to submit your renewal on time. Each year the State FOP gives us a deadline as to when our Lodge renewal package is due. All the members who have renewed by this date are included in this package. When the State receives all the renewal packages from the lodges, they prepare what's called an "export" (a list of all the paid-up members) and sends this export to the National FOP. The National FOP then prepares the National FOP cards and sends those cards to each lodge secretary (usually late December). The State then sends us a corresponding number of decals and courtesy cards. We then place all the received cards and decals in our Winter newsletter which is sent out in January. OK – now why you should renew on time. If you are late with your renewal you will not be included in the first export. Your renewal will go to the National in a subsequent export based on when you renewed. The later you renew, the later the export. The later the export, the longer you will have to wait for your cards and decals. Further, if you are entitled to the Survivor Benefit and the Death or Dismemberment Insurance, and you are 63 or over, if you do not renew before January 1st of the renewal year you will lose these benefits forever. So in conclusion, renew on time to get your cards and decals on time and to protect the benefits to which you are entitled. Hope this helps.

STATE FOP LAW ENFORCEMENT MEMORIAL

Of the 73 officers being honored this year 4 lost their lives in the Line Of Duty, 2 died in auto accidents, 1 lost his life to COVID-19, and 66 succumbed to 9-11 related illnesses. This year's ceremony was personal to us because one of our long time members, Chief of Brooklyn North, Gerald Nelson, was memorialized with his name added to the Memorial Wall.
